1 Key Distinction

Disinfection vs. Decontamination

- It's critical to know the difference between the two to establish the right plan for your business or facility

3 Components To Building a Successful Plan

Preparedness: What can I do now to ready my business or facility

- Selecting the right partners, signing necessary agreements, establishing processes and procedures – establish formal communication plan to build confidence of key stakeholders (employees, customers, and the general public)

Business Continuity: Getting back vs. staying back... safely

- Understanding the difference between an event vs. establishing the right plan to get your business back running and keep it running going forward in a safe way

- Begins with “preparedness” in selecting the right partner and doing everything you can to prepare for an event. This includes how your business will respond and your partner should clearly lay out the process on their end from initial identification through completion so there are no surprises or confusion when it matters most

Expertise

- There are a lot of companies advertising capabilities without the expertise to deliver safely and the “right way”. Whether disinfecting or decontaminating, choose a company that has the expertise to perform the job. Ask about their certifications and training programs. *“Who will be doing the work?”*

Experience

- Don’t be an experiment. Choose a company with the experience in performing the exact services you are requesting. It’s paramount to request referrals and explore a company’s history before selection. *“Can you walk me through your experience with infectious disease and handling large scale clean ups?”*

Scale

- With resources more limited than ever, it’s vital to ensure partners have the bench strength to deliver, enough resources when and where needed and the geographic presence to operate in a limited transportation environment. *“What is your footprint? How many trained professionals? Can you deploy more resources without the use of public transportation and how fast?”*

Supply Chain

- It’s no secret that our national supply chain is stretched to the brink. Choosing a partner with the right buying power and secure supplier network to get the proper PPE and supplies necessary to perform your job is another critical element in a successful plan. *“How deep is your supplier network, do you have reserve supplies, and what is your back up plan for shortages?”*


